RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OKLAHOMA CITY CREATING STREET IMPROVEMENT ASSESSMENT DISTRICT #1627; THAT PORTION OF THE SILVERHAWK PHASE I ADDITION KNOWN AS THE VILLAS AT SILVERHAWK WHICH INCLUDES LOTS 2-21 OF BLOCK 13 AND LOTS 8-17 OF BLOCK 14, SOUTH OF NW 178TH STREET AND WEST OF NORTH PENNSYLVANIA AVENUE, PURSUANT TO THE IMPROVEMENT DISTRICT ACT, 11OKLA. STAT. 2002 39-101, ET SEQ; ACKNOWLEDGING THAT A PUBLIC HEARING HAS BEEN HELD; DETERMINING THAT THE IMPROVEMENTS REQUESTED BY THE PETITIONER ARE ADVISABLE; DIRECTING THE CITY MANAGER TO TAKE ALL NECESSARY STEPS TO CAUSE THE IMPROVEMENTS TO BE CONSTRUCTED FOR STREET IMPROVEMENT ASSESSMENT DISTRICT #1627 AS SET FORTH IN THE REPORT OF THE CITY ENGINEER, INCLUDING THE USE OF A COMPETITIVELY BID CONTRACT FOR THE CONSTRUCTION OF SUCH IMPROVEMENTS.

WHEREAS, the City Clerk received a Petition for the Creation of a Street Paving Improvement Assessment District on November 6, 2017, pursuant to the Oklahoma Improvement District Act, 11 O.S. Stat 2011, § 39-101, *et seq.*, (“Act”), to create a Street Improvement Assessment District; and

WHEREAS, the Petition describes a proposed improvement district to include a portion of the Silverhawk Phase I Addition, Lots 2-21 of Block 13 and Lots 8-17 of Block 14, Oklahoma County; and

WHEREAS, the proposed district has been designated as Street Improvement Assessment District #1627, Oklahoma City, Oklahoma County, Oklahoma; and

WHEREAS, On January 16, 2018 (Item No. VIII.N.), the Mayor and City Council directed the City Engineer to prepare a report containing the preliminary plans and specifications, assessment plat, and an estimate of the total costs for the proposed Street Improvement Assessment District No. 1627; and

WHEREAS, the City Engineer has prepared his report for Street Improvement Assessment District #1627 and submitted it to the City Clerk; and

ADOPTED by the Council and **SIGNED** by the Mayor of The City of Oklahoma

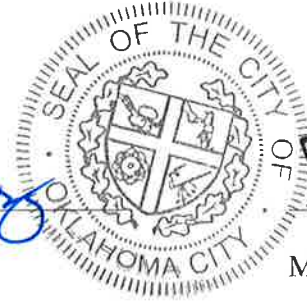
